### Who we are

We are R.K.Graphics Limited, a company registered in England & Wales with company number 2441894. Registered office is Graphic House, Honeywood Road, Whitfield, Dover, Kent CT16 3EH

### British Motorsport Events trades under the same GDPR policy as R K Graphics Limited.

This Privacy Policy also applies to any website operated by us irrespective of territory.

When you are using any of our connected websites, R.K.Graphics Limited is the data controller.

In this document "we", "our" or "us" as well as 'R.K.Graphics Ltd' refers to R.K.Graphics Limited.

### Introduction

We take the protection of your privacy and confidentiality seriously. We understand that all visitors to our website are entitled to know that their personal data will not be used for any purpose unintended by them and will not accidentally fall into the hands of a third party. We do not sell your data to third parties.

Our principle guidelines are simple, and we will be clear about the data we collect and why.

This Policy sets out the conditions under which we may process any information that we collect from you, or that you provide to us. It covers information that could identify you ("personal information") and information that could not. In the context of the law and this notice, "process" means collect, store, transfer, use or otherwise act on information.

We hope the sections below will answer any questions you have but, if not, please do get in touch with us.

# The information we collect about you

We collect information about you in a number of ways:

**Directly Provided Data** 

"Directly provided data" means when you visit our website, register with us, request quotations for work or place an order for products or services, you are providing data by filling in text boxes, clicking buttons and sending emails.

When you contact us generally, whether by telephone or by e-mail, we collect the data you have given to us in order to reply with the information you need.

When you give any information to us it may require a direct action from you and, as such, is deemed to be "directly provided data"

### **User Authorised Data**

"User authorised data" is when you give us permission to obtain your data from other businesses. It is unlikely we will ever request this but in the interests of GDRP compliance:

Depending on your settings or the privacy policies for other online services, you may give us permission to obtain information from your account with those other services.

For example, if another website jointly runs a promotion or competition with us, they will send us a list of the entrants who opted to receive our email newsletter as part of their entry. The information we obtain from such third parties does depend on your settings for that service or their privacy policies, so you should always regularly check what those are.

However, we will only arrange such joint promotions if it is made clear how the data will be shared with us.

This applies where you are asked if you would like to agree to receive/sign up for information on Facebook /Twitter/LinkedIn and other social media platform; making an appointment to visit our offices or factory. This applies generally when you use any social media platform or forum, including general conversations via telephone or by email.

"System collected data" is when our systems, or those of companies we engage with, collect information or data as you use our website or other services.

Whenever you use a website, or read email, there is certain information that gets created and recorded automatically by the system. For example:

- (a) When accessing www.rkgraphics.co.uk or any of our other websites, we use "cookies" (a small text file sent by your computer each time you visit our website or any of our other websites, unique to your R K Graphics limited account or your browser) to make it easier for you to use the websites, improve your experience with us or so we can log data relating to the pages you viewed and activities you carried out during your visit. These cookies may be "session" cookies (that last until you close your browser) or "persistent" cookies (that last until you or your browser deletes them). Some of the cookies we use are directly associated with your R K Graphics limited account (relating to things like the email address you gave us), and other cookies are not. There are more details on our cookie usage below.
- (b) In addition, the type of device you're using to access www.rkgraphics.co.uk and the settings on that device may provide us with information about your device, including what type of device it is, what specific device you have, what operating system you're using, what your device settings are, and why a crash has happened. What information we can be provided with depends on what type of device you're using and its settings. For example, different types of information are available depending on whether you're using a Mac or a PC, an iPhone or an Android phone. Your device manufacturer or operating system provider will have more details about what information your device makes available to us.

When you visit our premises, you should be aware the building and car park have CCTV in operation for the security of our customers, staff and the business. These systems may record your image during your visit.

### How we use information about you

We may use the information held about you to:

- Process your orders and manage your account
- Keep records for the proper administration of our business
- Update and manage our customer and marketing databases
- Ensure that the content of our website is presented in the most effective manner for you and your device
- If you agree, to email you about other products and services we think may be of interest to you
- Personalise emails that we send to you, including using your name to address emails and using your purchase history to
  provide relevant content
- Provide relevant social media content
- Carry out market research and analysis
- Administer and improve our website, including trouble-shooting, data analysis, testing, and research
- Measure and understand the effectiveness of advertising we serve to you and others and deliver relevant advertising to you
- Provide performance information so we may be able to manage, review and improve the efficiency of our business, its
  procedures and processes
- Confirm your identity and help prevent fraud
- Keep our website secure; comply with applicable law; enforce and apply our terms and conditions; protect the rights and property of R K Graphics Limited, our customers and others
- · To enhance the security of customers, staff and our premises by the use of CCTV cameras at our office/factory
- Insuring against or obtaining professional advice that is required to manage business risk.

# When we will share your information

We may share your information in the following circumstances:

- To business partners, suppliers, subcontractors and other third parties as necessary for the performance of any contract we enter with you, such as the delivery of an order or processing of a credit card payment
- To business partners, suppliers and subcontractors and other third parties as necessary for the performance of any contract we have with them, for example we use a third-party suppliers to send marketing emails and mail marketing brochures
- To analytics and search engine providers that assist us in the improvement and optimisation of our website
- In the event that we sell or buy any business or assets, in which case we may disclose your personal data to the prospective seller or buyer of such business or assets, under the protection of a non-disclosure agreement
- If R K Graphics Limited, or substantially all of its assets, are acquired by the third party, personal information held by it about its customers will be one of the transferred assets
- To protect our website from fraud and theft we may pass on personal information that is required to make identity
  checks and personal information that we obtain from making identity checks (including information relating to your
  age, name and location), together with account information to organisations, including law enforcement agencies,
  involved in fraud prevention and detection and credit risk reduction. Please note that these third parties may retain a
  record of the information that we provide to them for this purpose
- If we are under a duty to disclose or share your personal information in order to comply with any legal obligation
- In order to enforce or apply our terms and conditions and other agreements; or to protect the rights, property, or safety of R K Graphics Limited, our customers or others
- Insuring against or obtaining professional advice that is required to manage business risk

If your information enters or is freely available in the public domain, we have no control over what any individual third party may do with it. As a consequence, we accept no responsibility for their actions at any time.

### How we will not use your data

R K Graphics Limited will not share your information with other companies for their marketing purposes, and will not sell or seek to make financial gain from your information, aside from our own marketing activities.

We do not store or retain your financial information, such as credit card numbers. If we receive payment information as a result of a telephone order, we immediately delete any information we receive after processing the order.

# Access to/correction of your data

You have the right to request a copy of the information that we hold about you. If you would like a copy of some or all of your personal information, please email or write to us at the address below.

We want to make sure that your personal information is accurate and up to date. You may ask us to correct or remove information you think is inaccurate.

If you wish us to remove any personally identifiable information from our website e.g which you may have provided by giving us reviews/testimonials, please email or write to us at the address below.

After receiving the request, we shall take reasonable steps to verify your identity. This is important to safeguard your information.

Once this is clarified we will tell you when we expect to provide you with the information. Before doing so we shall take reasonable steps to verify your identity.

# Retention period for personal data

Except as otherwise mentioned in this privacy notice, we keep your personal information only for as long as required by us:

- to provide you with the services you have requested
- to comply with other law, including for the period demanded by our tax authorities
- to support a claim or defence in court

### If you live outside the UK

### **Cookie Policy**

We use cookies to help us to administer this website. We will not use cookies in combination with your personal information without your prior consent.

We use cookies for a number of purposes to allow us to provide some of the mechanisms for online shopping, to see how our website is being used so we can improve the site and to enable traffic monitoring.

### What are Cookies?

Cookies are tiny text files stored on your computer when you visit certain web pages. On the various websites operated by R K Graphics Limited we use cookies to keep track of what you have in your basket, and to remember you when you return to our site.

To order products on the R K Graphics Limited websites, you need to have cookies enabled. If you don't wish to enable cookies, you'll still be able to browse the site and use it for research purposes. Most web browsers have cookies enabled, but you are able to manage these by using the specific instructions for each individual browser (or mobile phone provider, where applicable).

Cookies can't harm your computer. We don't store personally identifiable information such as credit card details in cookies we create, but we do use encrypted information gathered from them to help improve your experience of the site. For example, they help us to identify and resolve errors that can sometimes occur on websites.

They are not computer programs, and cannot read other information saved on your hard drive. They cannot be used to disseminate viruses, or get user's e-mail addresses etc. We do have relationships with carefully-selected and monitored suppliers who may also set cookies during your visit to be used for remarketing purposes – in other words to show you different products and services based on what you appear to be interested in. Please note that we're not responsible for the content of external websites.

### **Our Cookie Policy**

To make full use of the online shopping and personalised features on R K Graphics Limited websites, your computer, tablet or mobile phone will need to accept cookies, as we can only provide you with certain personalised features of this website by using them.

Our cookies don't store sensitive information such as your name, address or payment details: they simply hold the 'key' that, once you're signed in, is associated with this information.

However, if you'd prefer to restrict, block or delete cookies from any website operated by the R K Graphics Limited brand, you can use your browser to do this. Each browser is different, so check the 'Help' menu of your particular browser to learn how to change your cookie preferences. You should be aware by doing so, there may be instances when certain features of our website may not function as a result.

Here's a list of the main cookies we use, and what we use them for:

- Ad Track, Affiliate: These cookies show us how you found our website and which website you came from. This lets us
  establish which marketing initiatives are most effective. They also allow us to reward external websites for directing
  you to us
- Pref: This is to do with safe browsing and is enabled on all browsers by Google to forewarn them of potentially dangerous sites. When you go on to any Google sites it is automatically installed. It does not contain any customer data apart from browsing history
- CookieID: This cookie allows our web servers to respond to your actions on the R K Graphics Limited websites, e.g. "Add
  to basket" or general browsing through the website. The website would not work for you if these cookies were not
  present
- FromAd: We use this cookie to determine if you arrived at <a href="http://rkgraphics.co.uk/">http://rkgraphics.co.uk/</a> or any of our other websites by clicking on an advertising link on external websites.
- Beginning with \_ut: These cookies enable R K Graphics Limited to use Google analytics. This software helps us take and
  analyse visitors to <a href="http://rkgraphics.co.uk/">http://rkgraphics.co.uk/</a> such as visitor numbers and how effective our marketing efforts are. All this
  information helps us improve the website for you. This data is used by R K Graphics Limited and Google, is never shared
  and doesn't contain any confidential information
- bronto\_ctrk: This is to enable us to track the performance of our e-mail campaigns from our email service provider, Bronto. After a customer has clicked through an e-mail link, a cookie is added to their session and then this is recorded in the reporting tools of Bronto's conversion tracking reporting tools
